### CITIZENS SUMMARY

#### Findings in the audit of the Seventh Judicial Circuit, City of North Kansas City Municipal Division

Comments

We evaluated the municipal division's internal controls over significant financial functions, including receipt and disbursement procedures, and its compliance with certain legal provisions, including rules governing fines, costs, and bonds. For the areas audited, no findings were identified.

In the areas audited, the overall performance of this entity was **Excellent**.\*

American Recovery and Reinvestment Act 2009 (Federal Stimulus) The Seventh Judicial Circuit, City of North Kansas City Municipal Division, did not receive any federal stimulus monies during the audited time period.

We have audited certain operations of the City of North Kansas City Municipal Division of the Seventh Judicial Circuit in fulfillment of our duties under Chapter 29, RSMo. The scope of our audit included, but was not necessarily limited to, the year ended September 30, 2010. The objectives of our audit were to:

- 1. Evaluate the municipal division's internal controls over significant financial functions.
- 2. Evaluate the municipal division's compliance with certain legal provisions.

Our methodology included reviewing written policies and procedures, financial records, and other pertinent documents; interviewing various personnel of the municipal division, as well as certain external parties; and testing selected transactions. We obtained an understanding of internal controls that are significant within the context of the audit objectives and assessed whether such controls have been properly designed and placed in operation. We also obtained an understanding of legal provisions that are significant within the context of the audit objectives, and we assessed the risk that illegal acts, including fraud, and violations of other legal provisions could occur. Based on that risk assessment, we designed and performed procedures to provide reasonable assurance of detecting instances of noncompliance significant to those provisions.

We conducted our audit in accordance with the standards applicable to performance audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Those standards require that we plan and perform our audit to obtain sufficient, appropriate evidence to provide a reasonable basis for our findings and conclusions based on our audit objectives. We believe that the evidence obtained provides such a basis.

The accompanying Organization and Statistical Information is presented for informational purposes. This information was obtained from the municipal division's management and was not subjected to the procedures applied in our audit of the division.

For the areas audited, we identified (1) no significant deficiencies in internal controls and (2) no significant noncompliance with legal provisions. No findings resulted from our audit of the City of North Kansas City Municipal Division of the Seventh Judicial Circuit.

A petition audit of the City of North Kansas City, fulfilling our obligations under Section 29.230, RSMo, is still in process, and any additional findings and recommendations will be included in the subsequent report.
